Dear parents,

Knowledge is a comfortable and necessary retreat and shelter for us in an advanced age and if we do not plant it while young it will give us no shade when we grow old. The format years of life seems as a perfect platform for a child. The Institution helps to grow into an intelligent, confident and successful human being. He/she should emerge as global citizen ready to face the biggest challenge of life. Students enjoy a balance between academic, sports and cultural activities as "Participation in all spheres of life is the key to the educational philosophy at **Prakruti Group of Institution.**"

Your children are going to build an important partnership between home and college striving for the above said goal. We would like to apprise you of the college itinerary to make your ward comfortable right from the day one so that he/she enjoys the formative college years.

1. School timings:

1.1 Monday – Saturday: 9.00 AM to 4.30 PM.

2. Uniform and personal grooming:

2.1 Boys and Girls :

Rd. Bangles, anklets and flowers are not permitted. Gold jewels with dropping are not allowed. (Except mere black watch)

Regular Uniform:

- a. I PUC and II PUC : Blazer, Pant, Belt and tie
- b. Black Shoes and Socks
- c. Uniform is compulsory on all working days from Reopening day.
- d. No one is permitted to wear colour dress if it is not announced by higher authority.
- e. No separate Sports Uniform for college Boys and girls.

2.2 Personal grooming:

- a. Hair should be neatly combed. Hair band for short hair and two plaits with long hair.
- b. Use only black colour rubber band, clips or hair band.
- c. Nails to be trimmed regularly (nail polish OR Mehandi is not allowed).
- e. Boys must be neat in appearance, clean shaven and no facial hair is allowed
- f. Boys' hair must be cut short and neat. Hair should not touch the collar.
- g. Hair must not touch the eyebrows when combed down.
- h. No long side burns are allowed. Hair must not be touching the ear.
- i. No fanciful haircut is allowed. Hair must not be tinted or dyed.
- j. No form of body piercing or body art will be allowed.
- k. Fancy and expensive hand watches are not allowed. **(Except mere black watch)**

Note: *The above discipline is going to be checked every day.*

The student should attend the classes regularly on time in uniform.

Children can wear colour dress on their birthdays and can offer books to the college library but are not permitted to distribute chocolates and sweets neither to teachers nor to students.

3. Personal Information and Leave Policy:

- 3.1 Personal information:** Columns given in the college calendar for personal information should be duly filled by given date.
- 3.2 Leave of absence:** A leave note in dairy should be sent duly signed by parents when ward is absent. In case of long absence more than 3 days meet the Principal to help the child to completet the pending work along with medical certificate.
- 3.3 Regular attendance:** Possessing minimum 75% of attendance is a must to appear for the final examination. Keep alive the child's interest and motivation in studies.
- 3.4 Signing of calendar:** To be done daily after getting the needful done we mentioned in it.
- 3.5** In case she/he is late or intends to leave the college early, suitable entries should be made in the calendar with the signature of the parent/ guardian and submit it to the class teacher.
- 3.6** Without the permission of the subject teacher and the Class teacher no student shall abstain from the class.

- 3.7 In case any student abstains from the class for a day or more he/she should submit leave application with the parent's/guardian's signature to the class teacher with principal's approval before attending the next classes.
- 3.8 In case any student abstains from the examination he/she should submit suitable written explanation for the period of absence and meet the principal personally along with the parent.

4. Discipline:

- 4.1 Snacks for the short break: Bring home made and nutritious Snacks only. Junk food is prohibited as it is unhealthy. A small napkin to be used in the dining table by those who are having lunch in the college. A water bottle should be carried to college. Those who bring food from home should bring vegetarian food only.
- 4.2 In case a student is irregular, inactive, uninterested in studies and misbehaves the Principal has the right to withdraw all the concessions and scholarship given to him and initiate disciplinary action against the students.
- 4.3 All the bonafied students of the college should have their Identity Cards and Calendars with them when they are in the campus.
- 4.4 The student are expected to wish the teachers respectfully when they meet first daily.
- 4.5 Except the interval time (break) no student should go out of the class without permission.
- 4.6 The students are expected to behave decently both within the college campus and outside. Misbehaviour of any kind will be suitably dealt with.

5 .RULES AND REGULATIONS

- 5.1 They should greet the visitors, elderly persons trust members whenever they spot them.
- 5.2 The student should interact with their friends / faculty members inside the campus only in English, if it is not implemented the necessary action will be taken by the class teacher and Principal.
- 5.3 The students should actively participate in all the activities taking place in the school and make the best use of the opportunities provided for their self-development. Attendance in uniforms during national day celebrations is compulsory.
- 5.4 The students should move in line while going to the Assembly and their classes after assembly.
- 5.5 Raising funds/ contributions/ selling tickets and lucky draws are strictly prohibited.
- 5.6 The students should refrain from taking part in any kind of political activities.
- 5.7 Without permission from the principal the student should not participate in any team games on behalf of the institution or in the name of the institution.
- 5.8 Sports Uniforms given to the team members should not be misused. They should be used only while representing the institution. After use, the uniforms should be washed and should be returned to the concerned authorities.
- 5.9 Playing before the commencement of the classes, during lunch hour is not allowed.
- 5.10 They should have full control over the language they use (Un parliamentarily words, derogatory words, should not be used while speaking to others.
- 5.11 The college Council election will be held in the beginning of the academic year. In case the code and conduct of election is violated, The Election will be deemed to void and in accordance with the decision taken by the management, the principal along with the staff council shall nominate student council.
- 5.12 Decision of the Principal/ staff council is final on all aspects related to the discipline of the students in the institution.
- 5.13 The students are expected to abide by the rules and regulations that are mentioned in the calendar and any violation of any of the disciplinary rules will be severely dealt with.
- 5.14 Transistors, Mobile phones, obscene pictures/magazines are strictly prohibited within the campus.
- 5.15 Miniskirts, Sleeveless tops, Gaudy dresses and Collarless T – Shirts are not allowed.
- 5.16 Students must not post or comment any inferior content on social media about the Institution.
- 5.17 In case any student is found to be irregular or if the teachers feel that the behaviour of a particular student is not up to the expected standard, he/she will suitably be advised and guided by the staff and the Principal. If student fails to mend him/herself in spite of the guidance given, the parents will be informed and summoned to the institution. Despite all these efforts, if a student continues to misbehave, his/ her T.C. will be issued as per the govt. rule ED sec.04 dated 11-04-2004.
- 5.18 For any kind of information the students/parents/guardians are advised to meet the concerned teacher/ principal in the college hours and avoid visiting the houses of the principal/Teachers and the Staff.

6 RULES AND REGULATION OF HOSTELERS

- 6.1 Student inmates of the hostel should follow the following rules and regulations of the hostel strictly.
- 6.2 Roommates should collectively maintain cleanliness and discipline within their respective rooms.
- 6.3 They should not unnecessarily enter into others room and chat with them. They should not handle others gadgets or spoil others belongings.
- 6.4 They should maintain dignity by respecting the teaching and non-teaching staff.

- 6.5 Inmates should follow the time table for using telephones (list is displayed on the notice board).
- 6.6 Whenever they leave the room they should ensure that the lights and fans are put off, it is each and every student's responsibility.
- 6.7 They should refrain themselves from touching electronic goods and main switch board.
- 6.8 Proper table manners should be maintained while taking food.
- 6.9 They should sleep only in their specified rooms and should not disturb others late night.
- 6.10 They should have full control over the language they use. Unparliamentarily words, derogatory word, should not be used while speaking to others.
- 6.11 Wakeup time, exercise time, study time, homework time and bed time should be strictly adhered to.
- 6.12 They should always think and interact with others by understanding others feeling, should not hurt anybody physically, intellectually and emotionally.
- 6.13 They should not involve in practical record work, assignment work and others activities during the prime time meant for studies.
- 6.14 Properties belonging to the Institution in the campus should not be damaged. Any kind of loss caused by the student will be recovered from the students (deducting from the hostel deposit for hostilities).
- 6.15 Unnecessarily loitering in the corridor, going to the roof top for playing, chitchatting is strictly prohibited.
- 6.16 Anything purchased from outside (while going for outing) should be shown to the concerned and each student can enter the hostel only after subjecting himself for check up.
- 6.17 No one should enter the premises of the neighbourhood properties adjacent to the campus.
- 6.18 No one is allowed to leave the hostel without a written request and permission by the concerned (Hostel warden, Hostel coordinator, teaching staff, principal).
- 6.19 Cell phones are strictly prohibited. The children who violate these rules will be subjected to suitable severe disciplinary action.
- 6.20 Male parents/guardians are not allowed within the girl's hostel premises.
- 6.21 Students are allowed to go for outings only once in a month. In case of ill health or any problem, students should immediately report to the warden / principal.
- 6.22 Proper time in the morning must be used to go through the subject wise lessons that are planned for the day and proper time should be used for completing home work in the evening.
- 6.23 Students are forbidden from bringing costly jewels, cameras, cell phones, Walkman, mp3/mp4, credit cards, chewing gums, playing card, friendship bands, body spray etc.
- 6.24 Students must report on opening and reopening day of the academic year as per the circular, In case of failure penalty will be imposed.
- 6.25 Bringing of any junk and other outside food items to the hostel and school by the students is banned.
- 6.26 Laundry facility is available and the expenses will borne by the students.
- 6.27 No Parents will allow to enter their wards room unless permission by the concern.

7. RULES FOR ADMISSION

- 7.1 A new admission to any class is allowed till June 30th of every year.
- 7.2 Application for admission should be made in the prescribed form, available in the school office and should be submitted along with the prescribed fees.
- 7.3 The correct date of birth and name of the child should be furnished with the necessary documents evidence.

8. INSTRUCTION TO THE PARENTS

- 8.1 The fees once paid will not be refunded or transferred.
- 8.2 The academic year is divided in two terms. **Term-I** is from June to October and the **Term-II** is from November to March. Irrespective of the time of admission a candidate should pay the entire fee. In case if a child leaves the college in the middle of the academic year he or she should clear all the fees to be paid.
- 8.3 Parents are requested to maintain all the receipts of college fees and vehicles fees till the end of academic year.
- 8.4 The college will not be held responsible for the loss or theft of the vehicle fare or the college fee sent through the drivers or children.
- 8.5 Parents must shoulder their responsibilities by co-operating fully in the task of education by seeing to the regular studies of the child and encouraging him/her, should attend all college functions without fail.
- 8.6 Occasional reports must accompany with the parents signature.
- 8.7 Parents are requested not to send their children with any valuables like gold ornaments, cash etc. If they do so, the management will not hold any responsibility for the loss.

- 8.8 Watch your children's individual record every day. Teacher's remark should be noted and signed.
- 8.9 Please see that your children do their homework regularly.
- 8.10 Parents are requested to meet the respective class teachers of the children at least twice in a month with the permission from the principal.
- 8.11 Parents are requested not to disturb the teachers during class hours. They can meet the teachers only after the college hours.
- 8.12 Please avoid walking up to the child's classroom. Parents are requested to wait in the office and ask for help required at the office desk.
- 8.13 In order meet Principal Pre-Appointment should be taken well in advance via Telephone or E-mail.

9. TERMS AND CONDITIONS REGARDING SCHOOL TRANSPORT

- 9.1 The transport fee is graded and will vary from point to point. The routes of the school buses are drawn up.
- 9.2 The bus will run only to the designated stops at each locality and not to the individual houses.
- 9.3 Students not in time for the bus will have to make their own arrangement on that day to come to school.
- 9.4 Parents are not allowed to travel to the College by College vehicles, unless provided during the occasion.
- 9.5 No reduction will be given for days of absence and midterm vacation.
- 9.6 Shouting and screaming in the moving bus is prohibited.
- 9.7 When the bus is in motion, students must not move around in the bus and no part of their body should be outside the bus. Students will be held responsible for any damage to a bus caused by negligence.
- 9.8 Senior students should offer seats to the juniors if enough space is unavailable.
- 9.9 Queue for getting into the bus.
- 9.10 Children travelling by school tempo must pay the tempo fare one month in advance and parents are requested to pay the tempo fare personally to the college office.
- 9.11 Sending the vehicle fare and college fees through drivers or children is strictly prohibited.
- 9.12 Those who like to cancel the bus facility in the middle of the month are required to pay full bus fare of that month.
- 9.13 When there is change of residence, advance information of change of residence address is to be forwarded to the college office.
- 9.14 The pick-up and drop timings may vary due to technical problem in the vehicles. In such case parents are requested to wait and co-operate. If it is too late parents are requested to contact school office.
- 9.15 The drivers are not authorized to stop buses at the designated stop unless directed by the office.
- 9.16 Students are not allowed to get down from the vehicle to purpose things from the shops.
- 9.17 Total fees of a transportation divided on the basis of Term 1 and Term 2, which could be paid monthly.

10. ARTICLE 60-CODE OF CONDUCT FOR STUDENTS

- A. The following acts and conduct on the part of the students will amount to mis behaviour towards teachers or any other employees of the school.
 - 10.1 Intentional disturbance of classes.
 - 10.2 Absence from class without the permission of the teacher /Principal.
 - 10.3 Bullying /intimidation of others.
 - 10.4 Eve-teasing/misbehaviour towards girl students.
 - 10.5 Damaging /disfiguration of college property.
 - 10.6 Propagating a strike disruption of classes.
 - 10.7 Association of communal/caste feeling among the students.
 - 10.8 Indulging in physical violence in any manner.
 - 10.9 Disobeying lawful orders of the Teacher/Principal.
 - 10.10 Bringing unauthorized people/articles inside the college.
 - 10.11 Theft/pilferage of college/students' property
 - 10.12 Any behavior unbecoming of a student.
 - 10.13 Indulging in acts of moral turpitude.
- B. In above acts of misconduct, Principal shall take suitable action as per observations of the disciplinary committee depending on the gravity of the misconduct. This may include;
 - a. Oral/written warning to the student and parents.
 - b. Suspension from attending classes/college for a specified period.
 - c. Recovery of loss to college property.
 - d. Issue of Transfer Certificate

11. LIBRARY REGULATIONS

- 11.1 Except while consulting the library staff, no student should involve in talking inside the library hall. Strict silence should be maintained in and around the library. The library staff has the right to expel any student or other visitor who violates disciplinary rules.
- 11.2 No damage should be caused to the magazines and books borrowed. If any periodical / book is damaged or lost, the student will be suitably fined. Books borrowed should be returned within the specified time.
- 11.3 Books borrowed from the library should be returned within 3 days.

12. LABORATORY REGULATIONS

- 12.1 No student is allowed to enter the laboratory without the permission of the staff in-charge.
- 12.2 Strict silence should be maintained in the laboratory.
- 12.3 Students should handle the equipment carefully. In case of any damage they will have to pay the fine.
- 12.4 Punctuality, regularity and regular submission of the records are the prerequisites of students.
- 12.5 Student should not leave the practical hall without the permission of the teacher in charge.
